REQUIREMENTS FOR HAULING PERMITS

1. A TRAFFIC SIGNAL CONTRACTOR, APPROVED BY NASSAU COUNTY DEPT. OF PUBLIC WORKS, MUST PERFORM ALL NECESSARY WORK ON THE COUNTY OWNED SIGNALS.
2. THE CENTER LANE OF THE EAST BRIDGE (NORTHBOUND) LONG BEACH BRIDGE, IS TO BE USED WITH NO OTHER TRAFFIC ALLOWED ON THE BRIDGE DURING THE CROSSING AND MAXIMUM OF TEN (10) MILES PER HOUR CRAWL SPEED IS TO BE MAINTAINED WITH NO SHIFTING OF GEARS OR SUDDEN STOPS OR STARTS.
3. CLEARANCES MUST BE VERIFIED ON ALL BRIDGES, THIS IS TO BE DONE BY CHECKING THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION (NYS DOT) WEBSITE LISTING ALL BRIDGES WITH RESTRICTIONS ON THEM. ALL LOADS WILL COMPLY WITH NYS DOT POSTINGS. NO VEHICLE EXCEEDING 20 TONS WILL BE PERMITTED TO CROSS THE BAYVILLE BRIDGE OR THE BARNUM ISLAND BRIDGE.
4. MOVEMENTS ARE TO BE MADE DURING HOURS SPECIFIED ONLY. WHEN WEATHER AND ROAD CONDITIONS ARE FAVORABLE. NO MOVEMENT TO BE MADE ON SATURDAYS, SUNDAYS OR HOLIDAYS (HOLIDAYS TO INCLUDE FROM 5:00 PM ON THE EVE OF THE HOLIDAY TO 10:00 AM ON THE DAY FOLLOWING THE HOLIDAY) UNLESS SPECIFICALLY STATED ON THE PERMIT.
5. THIS APPLICATION COVERS THE MOVEMENT OVER COUNTY ROADS ONLY. THEREFORE, PERMISSION TO USE STATE, CITY, TOWN, AND/OR VILLAGE THOROUGHFARES MUST BE OBTAINED FROM THE PROPER AUTHORITIES.
6. OVERHEAD WIRES, CABLES, SIGNAL/TRAFFIC LIGHTS, TREE LIMBS OR ANY OVERHEAD STRUCTURE MUST NOT BE DISTURBED WITHOUT FIRST OBTAINING WRITTEN PERMISSION FROM THE OWNERS THEREOF. COPY OF WRITTEN PERMISSION MUST ACCOMPANY THIS APPLICATION.
7. UPON APPLICATION FOR PERMIT TO MOVE EQUIPMENT OR STRUCTURES OVER 17 FT. HIGH, IT WILL BE NECESSARY TO HAVE A LETTER OF APPROVAL FROM NASSAU COUNTY TRAFFIC SIGNAL UNIT, THE LOCAL ELECTRICAL UTILITY (LIPA/PSEG-LONG ISLAND) AND THE LOCAL TELEPHONE UTILITY (VERIZON) INDICATING THAT THEY HAVE SURVEYED THE ROUTE YOU PROPOSE TO TAKE AND THERE WILL BE NO INTERFERENCE WITH THEIR AERIAL EQUIPMENT.
8. **INSURANCE:** APPLICANT MUST PROVIDE AT THEIR OWN EXPENSE PUBLIC LIABILITY & PROPERTY DAMAGE INSURANCE PROTECTING AS THE NAMED INSURED: THE COUNTY OF NASSAU, PLUS ANY MUNICIPALITY, ON ROUTE OF MOVEMENT, TO THE FULL LIMITS OF LIABILITY AS INDICATED: PERSONAL INJURY \$1,000,000 & PROPERTY DAMAGE \$500,000.

MOTOR VEHICLE CLAUSE TO READ " LIABILITY OF INSURANCE FOR PERMITS (PLURAL) ISSUED BY THE COMMISSIONER OF PUBLIC WORKS FOR OPERATION ON ROADS UNDER THE JURISDICTION OF NASSAU COUNTY OF ALL VEHICLES OWNED OR OPERATED BY "NAME OF PERMITTEE" IN EXCESS OF LEGAL WEIGHT, LENGTH, WIDTH, ETC. AS DESCRIBED IN ARTICLE 10, SECTION 385, OF THE VEHICLE TRAFFIC LAW AS AMENDED. (DO NOT PARTICULARIZE AS TO VEHICLE).

POLICY SHOULD COVER A TWELVE (12) MONTH PERIOD AND INCLUDE A TEN (10) DAY NOTICE OF CANCELLATION CLAUSE. PERMITS WILL BE RENEWED ON A SIX (6) MONTH BASIS UP TO THE DAY BEFORE EXPIRATION OF THE POLICY.

ANY LIABILITY INCURRED, AS THE RESULT OF THE PERMIT WHEN ISSUED SHALL REST SOLELY UPON THE PERMITTEE. THE PERMITTEE AGREES TO HOLD THE COUNTY OF NASSAU HARMLESS, AND DEFEND ANY ACTION BROUGHT AGAINST THE COUNTY OR IN THE OPTION OF THE COUNTY, PAY THE COSTS OF SUCH DEFENSE, AND TO PAY ANY AWARDS OR JUDGEMENTS MADE AGAINST THE COUNTY CONNECTED IN ANY WAY TO THE USE OF THIS PERMIT HEREIN, BY ANY COURT OR JUDICIAL BODY OR QUASI JUDICIAL BODY, TOGETHER WITH ALL COSTS, INTERESTS AND EXPENSES.

A. **MOTOR VEHICLE TRFFIC LAW**- Article 10, section 385, restricts you to the following maximum limits

Vehicle Width:	Up to 8' 0" inclusive of load
Vehicle Height:	Up to 13' 6" inclusive of load
Single:	Up to 35' 0" inclusive of load & bumpers
Combined Length:	Up to 55' 0" (48' Trailer) inclusive of load & bumpers
Combined Length:	Up to 60' 0" (45' Trailer) inclusive of load & bumpers
Weight:	Up to 80,000 lbs. inclusive of load

NASSAU COUNTY REQUIRES YOU TO OBTAIN PERMITS FOR VEHICLES WHICH EXCEED THE ABOVE RESTRICTIONS. WE HAVE TWO (2) TYPES OF PERMITS:

B. **STANDARD TYPE PERMIT:**

Permit duration up to one (1) year

Vehicle Width:	8' 0" to 12' 0"
Vehicle Height:	13' 6" to 14' 0"
Single Length:	35' 0" to 50' 0"
Combined Length:	50' 0" to 75' 0"

(Tractor & trailer)

Weight: if over 80,000 lbs.

C. **SPECIAL TYPE PERMIT:** (Proposed routing is required)

Permit duration up to six (6) months

Vehicle Width:	Over 12' 0"
Vehicle Height:	Over 14' 0"
Single Length:	Over 50' 0"
Combined Length:	Over 75' 0"

Weight: if over 80,000 lbs.

SELF-PROPELLED TRUCK CRANE

TWO-AXLE CRANES:

Maximum Axle Load	45,000 lbs.
Maximum Gross Vehicle Weight (Minimum Axle Spacing at 12ft.)	90,000 lbs.

FOUR-AXLE CRANES:

Must meet the following restrictions:

LOAD RATIO**

	23 ft. wheel base	27 ft. wheelbase
1 to 2.0	104,000 lbs.	110,000 lbs.

Maximum load on any single axle (in group) 40,000 lbs.

Maximum axle group loading (front or rear) 72,000 lbs.


Front to rear axle group load ratio greater than 1 to 2.0 **will not be permitted.**

SIX-AXLE CRANES:

Must meet all the restrictions for the FOUR-AXLE CRANES

SHOW DIMENSIONS BETWEEN CENTER LINE OF ALL AXLES TO THE NEAREST ONE (1) INCH.
SHOW DIMENSIONS BETWEEN CENTER LINE OF WHEEL TO CENTER OF WHEEL (TRACK WIDTH).
AT EACH AXLE LOCATION INDICATE THE MAXIMUM LOAD TO BE SUPPORTED BY THAT AXLE.
